Whereas the executants herein alongwith (1) P.V.Hamza, (2) K.M.Abdulla Koya, (3) Dr.K.P.Santha Kumar, (4) O.M.Damodharan (5) Karumapilly Kesavan Namboodiri (6) K.Abdul Azeez, (7) A.Aboobacker, (8) P.K.Krishnadas, (9) P.Kochunni Warrier, (10) K.Damodhara Menon, (11) K.Ramachandran, and (12) K.K.Mohammed had formed a trust under the name and style of Cherpalcheri Education Trust and registered the same as per document No.25 of Book IV of 1984,

SRO, Cherpalcheri with a capital of Rs.1,800/- (Rupees One thousand and eight hundred only);

And whereas several mistake have crept in the said deed, causing obstructions to the activities of the trust and it is considered expedient that the original trust deed should be suitably rectified so as to make it dynamic and viable for the purpose for which it has been formed, this rectification deed is being executed as follows:

The executants to this deed are the only members of the trust actively participating in carrying out the purpose of the trust have joined in this deed.

1. Clause 2 shall be amended as follows:

- 2. The office of the Trust shall be situated at Cherpalcheri, Palakkad District, Kerala or at such place or places as the Trustees may decide.
 - 2. Clause 3 shall be amended as follows:
- 3. The activities of the trust shall extend to the whole of Kerala State.

Clause 4(i) shall be amended as follows:

- 4(i). To establish, setup, construct, equip, maintain and run schools, colleges, Information technology centres, Industrial Education and training centres and Science and Technology Education and Research Institutions.
 - 4. Clause 8 shall be amended as follows:
- 8. The Trustees are authorised to accept gifts, bequests and donations of money, movable and immovable property and assets on such terms and conditions as may be deemed proper at their discretion including donations and gifts to the corpus of the trust.
 - 5. Clause 9 shall be amended as follows:

- 9. Mr.Shashi Kumar will be the Managing Trustee. The Trustees, under these presents, shall be entitled to appoint new Trustees as they deem fit. The term of office of the Trustees shall be three years. The number of Trustees may be increased if deemed necessary.
 - 6. Clause 10 shall be substituted as follows:

10. The number of trustees excluding Trustees appointed

under Clause 10 A shall not be less than three or more than five.

7. A new clause 10A shall be inserted as follows:

10A. The Trustees may co-opt persons with specialised knowledge and skill or eminence whom they consider will be of assistance to promote the objects of the trust as a Trustee. Such a Trustee shall hold office for such period and on such terms and conditions as the Trustees may decide. The persons appointed as Trustees under this clause shall not have voting power.

- 8. Clause 11 shall be amended as follows
- 11. The Trustees shall meet once in three months or as often as may be necessary.
 - 9. Clause 15 shall be amended as follows:

- 15. The Managing Trustee shall nominate any person to fill up the vacancy in the Board of Trustees and such trustee shall hold the office till the next election.
- 10. Clause 16 shall be amended as follows:

16. The Board of Trustees shall have the powers to remove a trustee, if he acts against the interests of the Trust.

- 11. Clause 17 shall be amended as follows:
- 17.All acts done or decision made for carrying out the objects of the Trust, if done, made or ratified by a majority of the Trustees shall be deemed to be acts of the Trust.
 - 12. Clause 18 shall be amended as follows:

- 18. If any difference of opinion arises at any time among the Trustees in relation to the Trust affairs, the opinion of the majority shall prevail and in the event of a "tie" amongst them, the Managing Trustee shall have a casting vote.
 - 13. Clause 24 shall be amended as follows:

- 19. The banking account of the Trust will be operated by the Managing Trustee or by any other person as the Trustees may by resolution decide.
- 14.Clause 25 shall be amended as follows and deemed to have been amended since inception of the trust.
- 25. The Trust is hereby established and shall be irrevocable.

- 15. A new clause 25A shall be inserted as follows:
- 25A. The provisions of the deed may be amended as may be deemed necessary by the trustees. The amendments shall however be subject to approval, if any required under the Income Tax Act, 1961 or any other Act governing taxation of income.
 - 16. Clause 26 shall be amended as follows:
- 26. The Managing Trustee shall have powers to represent the Trust and to take all legal proceedings in all civil, revenue and criminal Courts and all other Public Offices in relation to the Trust and its properties. All such expenses in connection therewith shall met by the Trust.
 - 17. Clause 27 shall be amended as follows:

CLEVEL STATISTICATION OF STATISTICAL STATI

27. The Managing Trustee shall have power to expend such sum or sums as deemed necessary for the proper maintenance of the Trust properties, pay all rates and taxes and meet all expenses relating to Trust and its properties.
